
FORCE has worked hard these last few months to meet the changing needs of those requiring hereditary cancer resources. Read on to learn about these and other milestones. With everything in our power, we will continue to do our best for you, our valued constituents.

#### RESEARCH

 For the first time, the FDA has approved a class of drugs known as PARP inhibitors to treat an aggressive type of metastatic prostate cancer that is common in men with BRCA and other mutations. FORCE helped match patients to the studies that led to these important approvals, helping to provide another treatment option to a subset of men with hereditary prostate cancer.

## **PUBLIC POLICY**

- 1. In 2018, Medicare implemented a national policy that essentially halted hereditary cancer genetic testing for its beneficiaries. Early this year, we successfully spearheaded efforts to change this restrictive policy, allowing local Medicare regions to cover testing for hereditary cancer mutations and providing greater access for people with cancer.
- 2. Supported legislation and policies aimed at easing the burden of the COVID-19 crisis on members of the hereditary cancer community, including expansion of medical services for Medicaid enrollees, funding to assure that stalled research resumes, access to 90 days of medications and home anticancer therapies, financial assistance for nonprofits serving the community and more.

## **EDUCATION AND AWARENESS**

- 1. Published our 200th XRAY review (eXamining the Relevance of Articles for You), building on our program to help people better understand news media articles about breast, ovarian, prostate and pancreatic cancer and to educate healthcare providers on how to communicate with their patients about these articles.
- Piloted our first continuing education opportunity at the Association for Oncology Nurse Navigators' virtual midwinter conference in collaboration with partners at the University of Southern Florida. This marks our commitment to enhancing patient and provider communication about hereditary cancer information.
- 3. Published our first Spanish language translation of an XRAY review on COVID-19 and cancer. This is one of several efforts to expand accessibility of our cancer education materials to a larger portion of the Hispanic community.

#### **SUPPORT**

- Created a dedicated COVID-19 resource webpage specifically for people affected by hereditary cancers. Organized five expert webinars and partnered on two others to address the physical and emotional challenges of COVID-19 facing our community. Topics addressed concerns about canceled doctor appointments, delayed screenings, treatment changes, how to support loved ones in treatment while practicing social distancing and fears about immune suppression.
- 2. Piloted a series of virtual support group meetings to replace our in-person gatherings to keep our community safe during the pandemic. We will continue to roll out this successful program across the country.
